Security

Point #1: In 1901, Connecticut passed the first U.S. state law regulating motor vehicles. It set a speed limit of



12 mph in cities and a whopping 15 mph outside. The Miles per Hour metric is used to this day and virtually everyone understands the metric. We need the same simplicity on Border Security metrics and we need it NOW. Currently our Country has no REAL definition of border security, and the past metrics used were far too complicated for the Government to figure out, let alone the American people. We must interject that we are tremendously disappointed that our Government has failed to, at the most basic level, determine who and who many

people are coming to America without legal presence. We must take the position that this task is paramount to success in the battle to end illegal immigration.

Action: We must all unite and agree to end the debate on this subject! We need to identify and utilize a metric that determines the effectiveness of our Border Security. If we neglect to identify this metric, track performance and make adjustments, we will never end the debate on border security. The metric must be:

- easily calculated,
- easily understood by the general public.
- *agreed upon by both sides of the immigration issue.*
- Not driven by "immigration economic/financial development" goals.
- Utilized to help determine "reasonable control" for 90% of our border.

Timing: 3 years

Completion Criteria: Border state governors and county sheriffs certify their borders are secured by using the "metric" as the gauge...

Note: Visa Overstays, which currently represent 40% of our Country's illegal immigration must be included in the computation of the metric.

Protecting American Workers

Point #2: It is inexcusable for American citizens and workers who are here legally authorized to work, to compete for jobs with illegal aliens.

While the intentions of the 1986 paper-based I-9 verification system were intended to be good, it was, and to this day, is easily manipulated with fraud.

Realizing a problem in the paper-based process, the 1996 Congress required the INS, to identify a new verification process that would work.

Congress now has focused on E-Verify. Unfortunately, this tool to eradicate the hiring of illegal aliens is still NOT mandatory. It is time, in today's creative, high-tech age, to close this loop in our immigration system and help eliminate any ambiguity as to who is working in our

County. We are confident that this can be accomplished without infringing on the civil liberties of anyone.

Action: Congress must once and for all, adopt a policy, completely fund it, and assure it is the bedrock of an ergonomic, reliable workplace verification system. Similar to the current E-Verify system, it must be made mandatory for every employer regardless of company size and set up in a manner that it does not create a “national” data base which could in the future be abused... Mandatory fines must be assessed to first time offenders of this system and the current “10 worker” trigger from the 1986 IRCA law, needs to be amended to read “any” workers.

Timing: 2 years

Completion Criteria: 85% of businesses in the United States are using the verification system

Note: E-Verify is based on the foundation that United States law prohibits employers from knowingly hiring or employing illegal aliens. The system allows employers to electronically verify employment eligibility. It is user friendly, free and exceptionally fast for an internet based program. This is a federal law that is voluntary for employers except for Federal Agencies. E-Verify is available in all 50 states.

- Six states—Alabama, Arizona, Louisiana, Mississippi, South Carolina and Tennessee—require use of E-Verify for new hires.
- Georgia, Utah, and North Carolina mandate E-Verify for employers that meet certain requirements...
- Many federal contractors participate in E-Verify as a condition of work contracts.

Citizenship

Point #3: America's culture must be preserved. The Declaration of Independence, The Constitution, The Bill of



Rights and other unique qualities of the United States, are all maintained by a just and enforceable immigration policy. American institutions rest solely on good citizenship said Theodore Roosevelt. They were created by people who had a background of self-government. New arrivals should be limited to our capacity to absorb them into the ranks of good citizenship. America must be kept American. Most disturbing is the giving away of citizenship. We find it difficult that those born in American jurisdiction are automatically considered American citizens, even though neither parent is a citizen of our Country. While studies suggests that the major motivator for illegal immigrants is the search for work and a better economic standing over the long term, adding hundreds of thousands of citizens annually via this

loophole is not in the best interests of our Country. How can the traits of our cherished America be taught to those whose parents have no allegiance to the country?

Action: We must manage immigration in such a manner so as to assure those we are welcoming; have ample time to assimilate to the American culture instead of overwhelming it. This will encourage patriotism and secure our traditions within their lifestyles. We believe there is precedent in U.S. law, and recommend revisiting the 14th. Amendment for the purpose of modifying the meaning and intent of the Citizenship Clause. Establishing who is and isn't granted automatic citizenship at birth will help bring our Country together on this important topic.

Timing: 18 months

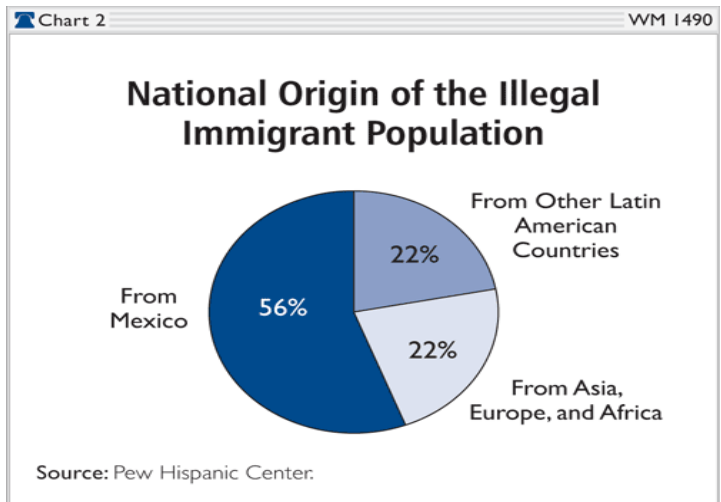
Completion Criteria: Our Law is changed.

The Current Illegal Alien Population:

We do not classify the current illegal alien population an item to be discussed under the umbrella of this Immigration Reform Platform.
